Notice of Publication of the Inspector's Report

Town and Country Planning (Local Planning) (England) Regulations 2012

The South Kesteven Local Plan was submitted to the Secretary of State for Housing, Communities and Local Government on 15th January 2019. The Secretary of State appointed Inspector, David Spencer BA (Hons) DipTP MRTPI to conduct the Examination of the Local Plan.

Notice is hereby given in accordance with Regulation 25 of the Town and Country Planning (Local Planning) (England) Regulations 2012, and section 20(8) of the Planning and Compulsory Purchase Act 2004 (as amended) that on 6th January 2020, South Kesteven District Council received the Inspector's Report on the Examination of the South Kesteven Local Plan. The Report sets out the Inspector's recommendations and his reasons for them.

The Inspector's Report concludes that the South Kesteven Local Plan satisfies the requirements of Section 20(5) of the 2004 Act and meets the criteria for soundness in the National Planning Policy Framework, provided that a number of modifications are made.

The Inspector's Report and the Local Plan documents, incorporating the Inspector's main modifications, are to be considered for adoption by Full Council on 30th January 2020. Upon adoption, the Local Plan will be the development plan for development management purposes under section 38 (6) of the Planning and Compulsory Purchase Act 2004 (as amended).
