The South Kesteven District Council (hereinafter called "the Council") in exercise of its powers under Sections 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended ("the 1984 Act") and of all other enabling powers, after consultation with the Chief Constable of Lincolnshire Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

1. This Order shall come into effect on the 29th August 2025 and may be cited as the South Kesteven District Council (Off-Street Parking Places) (Civil Enforcement) Order 2023, (Variation No.1) Order 2025.
2. In this Order, the expression "the Principal Order" shall mean the South Kesteven District Council (Off-Street Parking Places)(Civil Enforcement and Consolidation) Order 2023.
3. The Schedule to the Principal Order shall be varied to the following extent:-


The location of the car park is shown on the plan attached to this Order.


